

## ELIGIBILITY

### **The KTYD Rock and Roll Over Cash Contest**

NO CONSIDERATION OR PURCHASE IS REQUIRED TO ENTER OR WIN. CONSIDERATION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

This contest is open to California residents age 18 or older. Employees of Point Broadcasting LLC (PBLLC), dba Rincon Broadcasting (RB) and affiliated companies, contest sponsors and their respective household or immediate family members, are not eligible to enter. Compliance with the eligibility requirements will be determined solely by PBLLC/RB. All Federal, State and local laws and regulations apply. Void wherever prohibited or restricted by law. During each weekday of the contest period potential contestants of “The KTYD Rock and Roll Over Contest” must listen to the KTYD 99.9 FM between the hours of 8am to 9am and when requested by the morning personalities, be the designated caller to answer a rock music trivia question. The caller will then have nine (9) seconds in which to correctly answer the question. The caller can give one answer only.
2. If there is not a correct answer given, there will be another opportunity for another designated caller to give the correct answer to a different question between the hours of 11am and 2pm that same day.
3. If there is still no correct answer given, the \$100 for that day will “roll over” to the next day (becoming \$200). This will continue through the weekdays until there is a correct answer becoming the winner of the accrued cash.
4. Once there is a daily winner that week, the next cash prize opportunity will go back to \$100.
5. There is a guarantee of \$500 to be given away during each week of the two-week contest period. Prizes awarded will be American Express Gift Cards in increments of \$100. A grand total of \$1,000 is guaranteed to be given away during the contest period. The contest period will start on Monday, June 3, 2019, and will continue on each weekday through Friday, June 14, 2019, a total of ten (10) contest days.

Recorded promos will begin on Saturday, June 1, 2019, and will air numerous times randomly between 6am and 10pm throughout the duration of the contest period.
