

## ELIGIBILITY

### The KTYD “Shoreline 500” Contest

This contest is open to California residents in Santa Barbara and Ventura Counties age 18 or older. During The Shoreline 500 between the hours of 9am and 5pm on Friday, May 24, 9am and 5pm on Saturday, May 25, 9am and 5pm on Sunday, May 26, 9am and 5pm on Monday, May 27, KTYD WILL INVITE LISTENERS TO CALL THE STUDIO REQUEST LINE 805-879-5893 THREE TIMES each day TO AWARD CALLER NINE (9) FOR A PRIZE OF \$100.
4. Tuesday, May 28, 2019, one (1) Grand Prize Winner will be chosen at random from all valid entries to win the \$500 Grand Prize. The Grand Prize Winner will be announced on the KTYD Morning Mojo show in the 9am hour on Tuesday, May 28, 2019.
