

## ELIGIBILITY

### The KTYD “What’s that from?” Contest

NO CONSIDERATION OR PURCHASE IS REQUIRED TO ENTER OR WIN. CONSIDERATION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

This contest is open to California residents age 18 or older. Employees of Point Broadcasting LLC (PBLLC), dba Rincon Broadcasting (RB) and affiliated companies, contest sponsors and their respective household or immediate family members, are not eligible to enter. 3. The morning personalities will keep taking calls until the correct answer is given. The first listener with the correct answer will be a cash card valued at \$100.
4. There is a guarantee of \$400 to be given away the first week and \$500 the second and third weeks. A grand total of \$1400 is guaranteed to be given away during the contest period. The contest period will start on Monday, May3, 2021 and will continue on each weekday through Friday, May 21, 2021, a total of fifteen (15) contest days.

Recorded promos will begin Saturday, May1, 2021 and will air numerous times randomly between 6am and Midnight throughout the duration of the contest period. The promos will highlight how the contest works and will direct listeners to the KTYD website ([www.ktyd.com](http://www.ktyd.com)) for complete contest rules which will be prominently identified on the website
